This Privacy Policy applies between you, the User of this Website, and E&A Estates Limited, the owner and provider of this Website. E&A Estates Limited takes the privacy of your information very seriously. This Privacy Policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website. Please read this Privacy Policy carefully.

Definitions and Interpretation

1. In this Privacy Policy, the following definitions are used:

Term	Meaning
Data	collectively all information that you submit to E&A Estates Limited via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below headed Cookies;
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;
GDPR	the UK General Data Protection Regulation;
E&A Estates Limited, we or us	E&A Estates Limited, a company incorporated in England and Wales with registered number 14841452 whose registered office is at Suite 2a 6 Floor, Cobalt Square, 83-85 Hagley Road, B16 8QG;
UK and EU Cookie Law	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011 and the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2018;
User or you	any third party that accesses the Website and is not either (i) employed by E&A Estates Limited and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to E&A Estates Limited and accessing the Website in connection with the provision of such services; and
Website	the website that you are currently using, https://www.thevaultrealestate.co.uk/ , and any sub-domains of this site unless expressly excluded by their own terms and conditions.

2. In this Privacy Policy, unless the context requires a different interpretation:
- the singular includes the plural and vice versa;
 - references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy Policy;
 - a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - "including" is understood to mean "including without limitation";

- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

Scope of this Privacy Policy

- 3. This Privacy Policy applies only to the actions of E&A Estates Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, E&A Estates Limited is the "data controller". This means that E&A Estates Limited determines the purposes for which, and the manner in which, your Data is processed.

Data Collected

- 5. We may collect the following Data, which includes personal Data, from you:
 - a. name;
 - b. date of birth;
 - c. gender;
 - d. job title;
 - e. profession;
 - f. contact information such as email addresses and telephone numbers;
 - g. demographic information such as postcode, preferences and interests;
 - h. financial information such as credit / debit card numbers;
 - i. IP address (automatically collected);
 - j. web browser type and version (automatically collected);
 - k. operating system (automatically collected); and
 - l. a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected);

in each case, in accordance with this Privacy Policy.

How We Collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you;
 - b. data is received from other sources; and
 - c. data is collected automatically.

Data That is Given to Us by You

- 7. E&A Estates Limited will collect your Data in a number of ways, for example:

- a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
- b. when you register with us and set up an account to receive our products/services;
- c. when you complete surveys that we use for research purposes (although you are not obliged to respond to them);
- d. when you enter a competition or promotion through a social media channel;
- e. when you make payments to us, through this Website or otherwise;
- f. when you elect to receive marketing communications from us; and
- g. when you use our services;

in each case, in accordance with this Privacy Policy.

Data That is Received From Third Parties

- 8. E&A Estates Limited will receive Data about you from the following third parties:
 - a. referring sources;
 - b. credit reference agencies and identity verification providers, including Creditsafe and TransUnion, where relevant to affordability, identity, fraud prevention, or related checks; and
 - c. other third parties where you have authorised them to share information with us or where they are otherwise lawfully permitted to do so.
- 9. We will receive Data about you from the following publicly available third party sources:
 - a. referral sources; and
 - b. public records and other publicly available information where relevant to our services and legal obligations.

Data That is Collected Automatically

- 10. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content; and
 - b. we will collect your Data automatically via Cookies, in line with the cookie settings on your browser. For more information about Cookies, and how we use them on the Website, see the section below headed Cookies.

Our Use of Data

11. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
- a. internal record keeping;
 - b. improvement of our products / services;
 - c. transmission by email of marketing materials that may be of interest to you;
 - d. contact for market research purposes which may be done using email, telephone, fax or mail;
 - e. to assess applications, prevent fraud, and meet our legal and regulatory obligations;
 - f. to verify identity, assess creditworthiness and affordability, and support account or service onboarding; and
 - g. to comply with applicable legal, regulatory, accounting, tax, and anti-money laundering obligations;

in each case, in accordance with this Privacy Policy.

12. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed Your rights below).
13. For the delivery of direct marketing to you via e-mail, we will need your consent, whether via an opt-in or soft opt-in:
- a. soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under soft opt-in consent, we will take your consent as given unless you opt out;
 - b. for other types of e-marketing, we are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we will provide; and
 - c. if you are not satisfied with our approach to marketing, you have the right to withdraw consent at any time. To find out how to withdraw your consent, see the section headed Your rights below.
14. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.
15. We may use your Data to show you E&A Estates Limited adverts and other content on other websites. If you do not want us to use your data to show you E&A Estates Limited adverts and other content on other websites, please turn off the relevant Cookies (please refer to the section headed Cookies below).

Credit Reference and Affordability Checks

16. To help us assess applications, prevent fraud, and meet our legal and regulatory obligations, we may obtain information about you from credit reference agencies (CRAs).

17. We obtain this information via Creditsafe, which uses its data partner TransUnion to supply consumer credit and identity data.
18. Creditsafe Business Solutions Limited is authorised and regulated by the Financial Conduct Authority. FCA Firm Reference Number: 742313.
19. TransUnion International UK Limited is authorised and regulated by the Financial Conduct Authority. FCA Firm Reference Number: 737740.
20. The information we receive may include data relating to your identity, credit commitments, payment history, and public record information. This data is used solely for legitimate business purposes, including creditworthiness assessment, identity verification, and fraud prevention, in accordance with applicable data protection laws.

Automated Decision Making and Profiling

22. We may use automated systems and tools to support certain business processes, such as risk assessment, fraud prevention, affordability checks, identity verification, or record management.
23. These tools may analyse personal data using predefined criteria or rules to generate indicators, scores, or recommendations. However, we do not make decisions that have a legal or similarly significant effect on individuals based solely on automated processing. Any such decisions are subject to meaningful human review.
24. The use of these tools may influence the speed or level of review applied to an application or request, but individuals will not be subject to automatic rejection or adverse decisions without human involvement.

International Data Transfers

25. We do not transfer, store, or process personal data outside of the United Kingdom.
26. All personal data is handled exclusively within the UK and is not accessed by individuals, employees, or third-party providers located outside of the UK.
27. As such, no international data transfer safeguards are required.

Who We Share Data With

28. We may share your Data with the following groups of people for the following reasons:
 - a. any of our group companies or affiliates - to process or advise on any property related matter or transaction;
 - b. our employees, agents and/or professional advisors - to process or advise on any property related matter or transaction;

- c. third party service providers who provide services to us which require the processing of personal data - to process or advise on any property related matter or transaction;
- d. third party payment providers who process payments made over the Website - to process or advise on any property related matter or transaction; and
- e. relevant authorities - to prevent crime and money laundering;

in each case, in accordance with this Privacy Policy.

Keeping Data Secure

- 29. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you;
 - b. we store your Data on secure servers; and
 - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar, or both, in your browser when we use this technology).
- 30. Technical and organisational measures include measures to deal with any suspected data breach. If you suspect any misuse or loss or unauthorised access to your Data, please let us know immediately by contacting us via this e-mail address: Hello@thevaultrealestate.co.uk.

Data Retention

- 32. Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this Privacy Policy or until you request that the Data be deleted.
- 33. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your Rights

- 34. You have the following rights in relation to your Data:
 - a. **Right to access - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is manifestly unfounded or excessive. Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.**

- b. **Right to correct - the right to have your Data rectified if it is inaccurate or incomplete.**
 - c. **Right to erase - the right to request that we delete or remove your Data from our systems.**
 - d. **Right to restrict our use of your Data - the right to block us from using your Data or limit the way in which we can use it.**
 - e. **Right to data portability - the right to request that we move, copy or transfer your Data.**
 - f. **Right to object - the right to object to our use of your Data including where we use it for our legitimate interests.**
 - g. **Right to withdraw consent - where we rely on your consent to process your Data, you may withdraw that consent at any time.**
 - h. **Rights relating to automated decision making - where a decision is made solely by automated means and produces legal or similarly significant effects, you may be entitled to request human intervention, express your point of view, and contest the decision.**

36. If you are not satisfied with the way a complaint you make in relation to your Data is handled by us, you may be able to refer your complaint to the relevant data protection authority. 37. It is important that the Data we hold about you is accurate and current. Please keep us informed if your Data changes during the period for which we hold it.

Provision of Personal Data

38. The provision of certain personal data is primarily contractual and, in some circumstances, required to meet legal and regulatory obligations.
39. Personal data is required to:
- a. enter into and perform contracts with customers, suppliers, or business partners;
 - b. process orders, manage accounts, and deliver goods and services;
 - c. verify identity and prevent fraud; and
 - d. comply with applicable legal, regulatory, accounting, and tax obligations.
40. If you choose not to provide the personal data we request, we may be unable to:
- a. enter into a contract with you;
 - b. fulfil orders, supply goods, or provide services;
 - c. conduct necessary verification, compliance, or fraud prevention checks; and
 - d. as a result, our services may be delayed, restricted, or declined.
41. Where personal data is requested for optional purposes, such as marketing communications, providing this data is not mandatory, and you may withdraw your

consent at any time without affecting your ability to receive goods or services from us.

Links to Other Websites

42. This Website may, from time to time, provide links to other websites. We have no control over such websites and are not responsible for the content of these websites. This Privacy Policy does not extend to your use of such websites. You are advised to read the Privacy Policy or statement of other websites prior to using them.

Changes of Business Ownership and Control

43. E&A Estates Limited may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of E&A Estates Limited. Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this Privacy Policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
44. We may also disclose Data to a prospective purchaser of our business or any part of it.
45. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

Cookies

46. This Website may place and access certain Cookies on your computer. E&A Estates Limited uses Cookies to improve your experience of using the Website. E&A Estates Limited has carefully chosen these Cookies and has taken steps to ensure that your privacy is protected and respected at all times.
47. All Cookies used by this Website are used in accordance with current UK and EU Cookie Law.
48. Before the Website places Cookies on your computer, you will be presented with a message bar requesting your consent to set those Cookies. If any court or competent authority finds that any provision of this Privacy Policy, or part of any provision, is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this Privacy Policy will not be affected.
57. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
58. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
